This amount reflects the vesting of restricted stock (RSU) that vested on March 1, 2015, upon which date the reported closing price of the Company's common stock price exceeded an average of \$48 for the preceding 30 calendar days.

2. These shares were deducted to cover tax withholding obligations associated with the restricted stock award vesting on March 1, 2015.
